## A JOINT RESOLUTION

1 Proposing an amendment to the Constitution of the Commonwealth 2 of Pennsylvania, further providing for absentee voting. 3 The General Assembly of the Commonwealth of Pennsylvania 4 hereby resolves as follows: Section 1. The following amendment to the Constitution of 5 6 Pennsylvania is proposed in accordance with Article XI: 7 That section 14 of Article VII be amended to read: § 14. Absentee voting. 8 (a) The Legislature shall, by general law, provide a manner 9 in which, and the time and place at which, qualified electors 10 who may, on the occurrence of any election, be absent from the 11 [State or county] <u>municipality</u> of their residence, because their 12 duties, occupation or business require them to be elsewhere or 13 who, on the occurrence of any election, are unable to attend at 14

1 their proper polling places because of illness or physical 2 disability or who will not attend a polling place because of the 3 observance of a religious holiday or who cannot vote because of 4 election day duties, in the case of a county employee, may vote, 5 and for the return and canvass of their votes in the election 6 district in which they respectively reside.

7 (b) For purposes of this section, "municipality" means a

8 city, borough, incorporated town, township or any similar

9 general purpose unit of government which may be created by the

11 Section 2. (a) Upon the first passage by the General 12 Assembly of this proposed constitutional amendment, the 13 Secretary of the Commonwealth shall proceed immediately to 14 comply with the advertising requirements of section 1 of Article 15 XI of the Constitution of Pennsylvania and shall transmit the 16 required advertisements to two newspapers in every county in 17 which such newspapers are published in sufficient time after 18 passage of this proposed constitutional amendment.

19 (b) Upon the second passage by the General Assembly of this 20 proposed constitutional amendment, the Secretary of the 21 Commonwealth shall proceed immediately to comply with the 22 advertising requirements of section 1 of Article XI of the 23 Constitution of Pennsylvania and shall transmit the required 24 advertisements to two newspapers in every county in which such 25 newspapers are published in sufficient time after passage of this proposed constitutional amendment. The Secretary of the 26 27 Commonwealth shall submit this proposed constitutional amendment to the qualified electors of this Commonwealth at the first 28 29 primary, general or municipal election occurring at least three 30 months after the proposed constitutional amendment is passed by 19970H0171B2015 - 2 -
