A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth 2 of Pennsylvania, further providing for absentee voting.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby resolves as follows:
- 5 Section 1. The following amendment to the Constitution of
- 6 Pennsylvania is proposed in accordance with Article XI:
- 7 That section 14 of Article VII be amended to read:
- 8 § 14. Absentee voting.
- 9 (a) The Legislature shall, by general law, provide a manner
- 10 in which, and the time and place at which, qualified electors
- 11 who may, on the occurrence of any election, be absent from the
- 12 [State or county] municipality of their residence, because their
- 13 duties, occupation or business require them to be elsewhere or
- 14 who, on the occurrence of any election, are unable to attend at

- 1 their proper polling places because of illness or physical
- 2 disability or who will not attend a polling place because of the
- 3 observance of a religious holiday or who cannot vote because of
- 4 election day duties, in the case of a county employee, may vote,
- 5 and for the return and canvass of their votes in the election
- 6 district in which they respectively reside.
- 7 (b) For purposes of this section, "municipality" means a
- 8 city, borough, incorporated town, township or any similar
- 9 general purpose unit of government which may be created by the
- 10 <u>General Assembly</u>.
- 11 Section 2. (a) Upon the first passage by the General
- 12 Assembly of this proposed constitutional amendment, the
- 13 Secretary of the Commonwealth shall proceed immediately to
- 14 comply with the advertising requirements of section 1 of Article
- 15 XI of the Constitution of Pennsylvania and shall transmit the
- 16 required advertisements to two newspapers in every county in
- 17 which such newspapers are published in sufficient time after
- 18 passage of this proposed constitutional amendment.
- 19 (b) Upon the second passage by the General Assembly of this
- 20 proposed constitutional amendment, the Secretary of the
- 21 Commonwealth shall proceed immediately to comply with the
- 22 advertising requirements of section 1 of Article XI of the
- 23 Constitution of Pennsylvania and shall transmit the required
- 24 advertisements to two newspapers in every county in which such
- 25 newspapers are published in sufficient time after passage of
- 26 this proposed constitutional amendment. The Secretary of the
- 27 Commonwealth shall submit this proposed constitutional amendment
- 28 to the qualified electors of this Commonwealth at the first
- 29 primary, general or municipal election occurring at least three
- 30 months after the proposed constitutional amendment is passed by

- 1 the General Assembly which meets the requirements of and is in
- 2 conformance with section 1 of Article XI of the Constitution of
- 3 Pennsylvania.
