A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania further providing for the disposition of
- 3 taxes on aviation fuel.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 the Commonwealth of Pennsylvania is proposed in accordance with
- 8 the provisions of Article XI thereof:
- 9 That section 11, Article VIII be amended to read:
- 10 § 11. Gasoline taxes and motor license fees restricted.
- 11 (a) All proceeds from gasoline and other motor fuel excise
- 12 taxes, motor vehicle registration fees and license taxes,
- 13 operators' license fees and other excise taxes imposed on
- 14 products used in motor transportation after providing therefrom
- 15 for (a) cost of administration and collection, (b) payment of
- 16 obligations incurred in the construction and reconstruction of
- 17 public highways and bridges shall be appropriated by the General
- 18 Assembly to agencies of the State or political subdivisions
- 19 thereof; and used solely for constriction, reconstruction,

- 1 maintenance and repair of and safety on public highways and
- 2 bridges [and air navigation facilities] and costs and expenses
- 3 incident thereto, and for the payment of obligations incurred
- 4 for such purposes, and shall not be diverted by transfer or
- 5 otherwise to any other purpose, except that loans may be made by
- 6 the State from the proceeds of such taxes and fees for single
- 7 period not exceeding eight months, but no such loan shall be
- 8 made within the period of one year from any preceding loan, and
- 9 every loan made in any fiscal year shall be repayable within one
- 10 month after the beginning of the next fiscal year.
- 11 (b) All proceeds from aviation fuel excise taxes, after
- 12 providing therefrom for the cost of administration and
- 13 collection, shall be appropriated by the General Assembly to
- 14 agencies of the State or political subdivisions thereof and used
- 15 solely for: the purchase, construction, reconstruction,
- 16 operation, and maintenance of airports and other air navigation
- 17 <u>facilities; aircraft accident investigation; the operation,</u>
- 18 maintenance and other costs of aircraft owned or leased by the
- 19 Commonwealth; any other purpose reasonably related to air
- 20 <u>navigation; and costs and expenses incident thereto and for the</u>
- 21 payment of obligations incurred for such purposes, and shall not
- 22 be diverted by transfer or otherwise to any other purpose.
