FOREWORD

Act Number 2, which was adopted March 15, 1967 and ratified by the voters at the primary election on May 16, authorizes the holding of a Constitutional Convention, to convene on December 1, 1967, for a period of three months.

The Act provides also for a Preparatory Committee to consist of the Lieutenant Governor and twelve officers of the General Assembly, listed opposite. A major function of this Committee is the compiling of basic information which will assist the Convention delegates in carrying out their responsibilities effectively.

To this end, the Preparatory Committee has commissioned preparation of a series of Reference Manuals, of which this is one. This volume presents, for the delegates' information, a detailed listing of publications cited in the four reference manuals on the subjects to be considered by the Convention, along with other writings on the general subject of Constitution-making. Efforts will be made to have available in a Convention reference library a copy of every publication listed in this bibliography.

The bibliography was compiled by Mrs. Florence C. Steigerwalt, Reference Librarian for the General Library Division of the Pennsylvania State Library. She brought a wealth of experience to her assignment and a penchant for accuracy and detail that assure an outstanding bibliography. The Committee appreciates also the cooperative spirit of Dr. Ernest E. Doerschuk, State Librarian, in releasing Mrs. Steigerwalt for this assignment.

PREFACE

This bibliography on the constitutional process and on constitutional revision has been compiled by members of the staff of the Pennsylvania State Library for the use of the Pennsylvania Constitutional Convention of 1967-1968, which will meet in Harrisburg in December. It itemizes books, government publications, magazine articles and pamphlets dealing with the constitutional experience of Pennsylvania and other states, and seeks to incorporate the references used by authors of The Preparatory Committee Reference Manuals.

The Constitutional Convention is to be a limited one, concerning itself only with the issues of taxation and state finance, local government, legislative apportionment and the judiciary. As a result these areas are stressed and other important issues barely touched upon in this bibliography. However, many of the entries in Sections I and II deal with a number of topics of constitutional concern, and the bibliographies listed in Section II will provide further material on varied subjects. Note especially *A Selected Bibliography on State Constitutional Revision*, 2d ed., published in 1967 by The National Municipal League, complete with a supplement by Myron Fink.

In the time allotted it was not possible to verify all of the items. They have been entered here as found, in the hope that a later search may complete or correct them. For these and other inevitable errors, your pardon.

Our thanks to the people who helped in the project, especially Mrs. Martha Bowman, Reference Librarian in the Law Library, and Mr. Robert Stewart of the Government Publications Section. And many thanks also to the several typists and other aides who assisted in so many ways.
